RESOLUTION :

Government is pleased to sanction to the Municipal Councils and Corporations for the year 1975-76 grants equal to the following share of the Entertainment Duty realised within the areas of Municipal Corporations and Municipal Councils :-

1) Municipal Corporations ..	10%	} of the total collection made in the previous year.
2) 'A' Class Municipal Councils ..	30%	
3) 'B' Class Municipal Councils ..	35%	
4) 'C' Class Municipal Councils ..	40%	

2. The Municipal Councils in the Aurangabad Division are at present receiving compensation in lieu of Entertainment Tax. Government is pleased to direct that these Municipal Councils should be paid an amount equal to the compensation paid at previous rate or the amount arrived at one the basis of the orders in para 1, whichever is higher.

3. Under Government Circular, Urban Development, Public Health and Housing Department No. BCC 1075/14468-A, dated the 8th April 1975, the Municipal Councils were advised to abolish the practice of carrying night soil as head-load by December 1975. They were also informed that failure to stop this practice will result in the discontinuance of discretionary grants paid by Government. Government is now pleased to direct as follows :

- 1) An Amount equal to 25% of the above grant shall be cut during the current year in the case of Municipal Councils which do not discontinue the practice by 31st December 1975;
- 2) In respect of those Municipal Councils which do not discontinue the practice by 31st December 1976, an amount equal to 50% of the grant shall be cut during the financial year ending 31st March 1977; and
- 3) No grants will be paid in the financial year 1977-78 to those Municipal Councils which do not discontinue the practice by 31st December 1977.

4. The expenditure on account of payment of Entertainment Duty grant should be debited to budget head "363 - compensations and Assignments to local bodies and Panchayat Raj Institutions (f) Other Misc. Compensations and Assignments (f) (1) Assignments of Share of Entertainment Duty to Municipal bodies - Demand No. 82." Necessary budget grants have already been placed at the disposal of the Director of Municipal Administration, Bombay for this purpose under Government, Resolution, Urban Development, Public Health and Housing Department, No. BUD 2575/19418/25548/P, dated the 31st May 1975. The Director of Municipal Administration should report to Government the amount of entertainment duty grant payable to the local bodies in the current year immediately.

5. This resolution issues with the concurrence of Finance Department vide un-official reference No. 1145/75/F-17, dated the 28th July 1975.

6. The Collectors should immediately report to the Director of Municipal Administration, Bombay the amount payable to each Municipal Council so that the necessary allotment can be placed at their disposal.
